We now have our day separated into 2 units of service that afford participants the opportunity to engage in meaningful and functional activities related to their social, independence and vocational goals. We offer services in four distinct categories: Day Activity, Community Services, Career Prep, and Employment Services. We continue to offer the opportunity to over 40 individuals to earn wages on our Mobile Work Crews and Enclaves.

Day Program participants at Bridging the Gap and our Seniors Program joined in the fun for our Halloween Dance on October 30, 2009, our Christmas Dance on December 23, 2009, and our Valentines Dance on February 12, 2010, all held at Bridging the Gap.
