Profile of Service

Mr. James "Jimmy" Long, Jr. was a 50 year old man who resided in Bennettsville, SC. He had a C-5 spinal cord injury when he was 22 years old that resulted in quadriplegia. Mr. Long was a very intelligent young man with physical limitations only. Despite his physical condition, Mr. Long graduated from USC in 1995 with a BS in Science and was a good writer and speaker. While at USC, he began working as an advocate for the disabled. Mr. Long assisted in getting increased transportation for the physically challenged community in Columbia. They began with two vans and have increased to twenty five. He was instrumental in getting electric doors installed at the USC campus as well as more handicapped parking spaces. He wrote grants to get increased hours with CLTC. One of Mr. Long's projects was to get electric doors installed at the main entrances of doctors offices and the project was complete in one week. In 1993, he was appointed to Mayor Cobles's Yellow Light Committee whose purpose was to study traffic congestion during peak traffic hours. When Mr. Long completed college, he started projects in his neighborhood for disabled persons. He wrote a grant for exercise equipment to be provided to his local recreational center for the physically handicapped, assisted in fund raisers for different churches, and volunteered in his local organization. Mr. Long worked hard wherever he saw a need in his community. In August of 2006, he heard about a fellow quadriplegic who lost his home and moved into a small mobile home with no air conditioning and temperatures over 100 degrees.

Mr. Long was able to secure two air units for the man the day after hearing of his problem. Mr. Long was credited with organizing the local Spinal Cord Association and was on its state board. He was also the founder of Priority One Home Health



Care. Sadly, Mr. Long died on December 19, 2007.

It is flu season again. Let's be prepared!

Influenza is a contagious respiratory disease caused by a virus. Therefore, it cannot be treated with antibiotics. Normally, flu season lasts from November through March. Common symptoms of the flu include: fever, headache, extreme tiredness, dry cough, sore throat, runny nose, muscle aches, and stomach symptoms such as diarrhea and vomiting.
