

The Family Advisory Council is sponsoring a Quilt Raffle to raise funds to support After Hours events. The quilt is completely handmade and has a beautiful Double Wedding Ring pattern with hearts stitched in the center of each ring. The measurements are 92 1/2 inches by 86 inches. It is a beautiful work of art made by Ms. Barbara Wainwright who resides in Rockingham, NC. Ms. Wainwright is retired but devotes her time to making beautiful quilts completely by hand without using a machine or even a quilt frame. Her quilts vary in price depending on complexity but start at \$150 for the simplest type. Our quilt is of medium complexity; however, she gave us an incredible discount and the cost was covered by a donation from a FAC member. Tickets are \$1.00 and the drawing will be held on Tuesday, February 24 at 5:30 pm at the beginning of the Board of Directors meeting. Participants need NOT be present to win. The winner will be called after the Board of Directors meeting is finished. The winner will be photographed receiving the quilt and sent out in press releases to local media.

Normally, the FAC sponsors only one fundraising event (the Gas Raffle) each year. This is due in large part to donations to the FAC from charitable foundations in previous years. Unfortunately, the FAC did not receive those donations this past year and is short on funds. After some discussion the FAC decided on a few fundraising ideas that will be spaced out over the year. These events will include the quilt raffle, selling barbecue plates, participating in charity sales at local department stores, and the annual gasoline raffle. Other events may be added or removed

from the list as determined by the FAC. As always, FAC funds are used to sponsor events for DCDSNB consumers throughout the year. The annual events are the Valentine Social, a spring picnic, the (summer) day at the movies, the Fall Harvest Dance, the Thanksgiving Dinner and the Christmas Party.

The next FAC meeting will be held on Monday, April 20 at 6:00 pm at the Scott Center located at 201 North Damascus Church Road in Hartsville. A local attorney will attend to present information on Living Wills and Guardianship issues as it relates to parents / guardians of consumers. The Family Advisory Council (FAC) is an organization of supporters of DCDSNB that is comprised of interested consumers, family members and advocates. The FAC promotes understanding between families and the board by providing a forum for the exchange of information, ideas and concerns, as well as a chance to meet and fellowship with other family members.
